All entries must be **RECEIVED** by the Florida Wild Mammal Association by: **September 6, 2011**.

There will be a \$5.00 entry fee for each photo (no entry fee for Young Nature Photographers 17 and under). Make checks payable to Florida Wild Mammal Association.

**FORMAT: Photo Prints only. No frames please.**

All entries must be photograph prints 8" x 10" , 8" x 12" or 8 ½" x 11". Prints must be mounted on black or white 11" x 14" foam board or mat board with the entry form (**model release if needed**) attached to the back.

To submit an entry into the contest, photographers must be at least 18 years of age or submit a release from a parent or legal guardian.

**All non- donated prints not picked up by Nov. 1, 2011 will be considered donations to the Association and will be sold to help support the Association.**

The original slide, negative or digital file may be requested. Scans of entries may be posted on the Florida Wild Mammal Association website at low resolution.

PRIZES will be awarded to **Best in Show**, 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place for division, Youth and Adult.

All entries will be on display at the Wood Stork Festival, Saturday, Oct. 8, 2011.
